

REPORT TO ABERDEENSHIRE COUNCIL – 18 NOVEMBER 2021

REPRESENTATION OF THE PEOPLE ACT 1983 – REVIEW OF POLLING DISTRICTS AND POLLING PLACES

1 Reason for Report / Summary

1.1 This report provides the Council with information regarding polling districts and polling places in the Aberdeenshire Council area and recommends changes to the designation of certain polling places within said polling districts.

2 Recommendations

The Council is recommended to:

- 2.1 Agree the following changes to the designation of polling places in the Aberdeenshire Council area and attached as Appendix 1 of this report.
- 2.2 Notwithstanding recommendation 2.1, approve contingency arrangements for the identification of polling places in any case where a venue becomes unavailable at short notice and note that the Returning Officer has a delegated authority to agree any further changes that may be required in the preparation for the Scottish Local Government Elections 2022 or any intervening election event.

3 Purpose and Decision Making Route

- 3.1 This report seeks to advise members of the legislative duty placed upon the Council, in terms of the Electoral Registration and Administration Act 2013 ("the 2013 Act") to undertake a review of parliamentary polling districts and polling places under the Council's control.
- 3.2 The purpose of undertaking the review is to ensure that reasonable facilities are provided for voting and that polling places are accessible to all electors, including those with a disability, so far as is practicable.
- 3.3 Following consultation, this report has come back to Full Council to complete the formal decision-making route.

4 Discussion

- 4.1 Section 18 of the 2013 Act requires that the Council conducts a review of all polling districts and polling places every five years.
- 4.2 In any event, the Council has a policy of reviewing polling arrangements on an ongoing basis and exploring alternative facilities wherever these are brought to the attention of the Returning Officer. Accordingly, the designation of new polling places is not uncommon and a number of these take place in the period between each formal review.

4.3 In addition, the Council must seek to ensure, so far as possible, that polling places are accessible to any elector with a disability and take this into account when designating any new polling place. It is a requirement that the polling place for any polling district is located within that district, unless there are special circumstances making it desirable to designate a venue wholly or partially outside said polling district.

- 4.4 It was the original intention of the Elections Team, subsequent to reporting to Full Council on 16 January 2020 (Item 9, Page 96) and having completed a sixweek period of consultation between 4 February 2020 and 17 March 2020 with various stakeholders for the identification of alternative venues for polling places, to report back to Full Council for agreement of any subsequent changes to the designation of polling places in the Aberdeenshire Council area. However, having considered the challenging situation with the coronavirus outbreak the review of polling districts and polling places was postponed until further notice. (It should also be noted that, in the intervening period, the 2018 Review of UK Parliamentary Constituencies was formally abandoned with the passing of the Parliamentary Constituencies Act 2020, which received Royal Assent on 14 December 2020; the next review will be conducted between 2021 and 2023). Following the lifting of most of the coronavirus restrictions and the country moving beyond the level zero rules on 9 August 2021, the Elections Team has been able to complete its investigations and now make recommendations to Full Council regarding alternative polling place venues which could be used at future electoral events.
- 4.5 It is recommended that Full Council agree to retain the existing polling places as previously agreed by Full Council on 16 January 2020, save for the following proposed changes to polling places (which are also highlighted in bold within the list of Polling Districts and Polling Places attached as Appendix 1 to this report):

4.6 Concurrent with the proposed recommendations, the Elections Team have considered all options available to it for removing schools from the list of polling places for the Aberdeenshire Council area.

- 4.7 The following schools are currently listed as polling places in the Aberdeenshire area:
 - Arnage School
 - Aucherellon Primary School, Ellon
 - Ballogie Nursery School Building
 - Banchory Devenick School
 - Buchanhaven School, Peterhead
 - Clerkhill School, Peterhead
 - Crudie School
 - Dales Park School, Peterhead
 - Drumblade School Nursery Building
 - Easterfield School
 - Meiklemill Primary School, Ellon
 - The Anna Ritchie School, Peterhead
 - Tough School
 - Westfield School, Fraserburgh
- 4.8 The proposed recommendations would mean that Ballogie Nursery School Building, The Anna Ritchie School in Peterhead and Westfield School in Fraserburgh would no longer require to be used as polling places. Easterfield School can no longer be used as a polling place as it is currently mothballed.
- 4.9 While removing all schools from the list of polling places for the Aberdeenshire Council area remains a challenge, the Elections Team will continue to consider any alternative venues as part of its policy of reviewing polling arrangements on an ongoing basis and exploring alternative facilities wherever these are brought to the attention of the Returning Officer.
- 5 Council Priorities, Implications and Risk
- 5.1 This report helps deliver the Strategic Priority "Infrastructure" within the Pillar "Our Environment"; underpinning this priority is the key principle of having the right people, in the right places, at the right time.

4.3. Positive Impacts

Age (Older)	Older people will benefit from the review process in that a thorough assessment of polling places includes situating polling stations in venues which are readily accessible and on a ground floor level. This, therefore, will be beneficial to elderly voters who may have some mobility issues.
Age (Younger)	Younger people will benefit from appropriate polling venues being identified for the long-term and this will continue until they are of voting age. In the shorter term, the identification of community polling venues, as opposed to the use of school buildings, will prevent pupils missing schooling on the occasion of any election.

Disability	A fundamental tenet of the review process is to ensure the provision of suitable polling arrangements for all electors, including those with a disability. Polling premises are assessed for their suitability for wheelchair users in terms of interior space, door width, level flooring, smooth car park surfaces, toilets for voters with a disability, clear internal light and so on.

Letters were sent to all local access panels, to Capability Scotland, Grampian Society for the Blind and Cornerstone and their views invited on the needs of those whom they represent, in respect of election polling provision. In a wider sense, all community councils in Aberdeenshire were also invited to submit their views on behalf of local residents, including the young and the elderly.

4.7. Evidence of engagement

The views of stakeholders were taken into account when reviewing the designation of polling places within the Aberdeenshire area.

4.8. Overall Outcome

No Negative Impacts Identified.

The aim of the review process is to ensure suitable, local polling provision for residents and to try to make certain that there are no unnecessary barriers to voting for those who may have any form of disability. The outcomes are therefore all positive for voters with a disability and also for elderly voters and young people in different respects. The impact on all other protected characteristic groups is neutral.

4.9. Improving Relations

External consultation took place with local access panels and other organisations representing the interests of voters with disabilities

(such as Capability Scotland, Grampian Society for the Blind and Cornerstone).

4.10. Opportunities of Equality

Local authorities have a duty to review the accessibility of all polling places to disabled voters and ensure that every polling place, and prospective polling place, for which it is responsible is accessible to disabled voters 'so far as is reasonable and practicable'.
